Unless otherwise indicated, all capitalised terms in this letter shall have the same meaning as described in the Prospectus for the Underlying Fund dated 5 March 2021, Hong Kong Covering Document for the Underlying Fund dated March 2021 and the latest Product Key Facts Statement of Barings Asia Balanced Fund (collectively the "Hong Kong Offering Documents").

We have been informed by the director of Baring International Fund Managers (Ireland) Limited of the following changes to the underlying fund corresponding to the Investment Choice (the "**Underlying Fund**"). The changes have been effective on 5 March 2021. As the unitholders of the Investment Choice, the following changes applicable to the Underlying Fund may have implications for your investment.

Enhancement of risk disclosures on Environmental, Social and Governance ("ESG") integration

To comply with the EU Sustainable Finance Disclosure Regulation (Regulation (EU) 2019/2088) ("SFDR"), the Hong Kong Offering Documents have been updated to enhance the risk disclosures regarding the Underlying Fund's approach to ESG integration. The Investment Manager of the Underlying Fund integrates ESG information into the investment process across all asset classes. Please refer to the revised Hong Kong Offering Documents for details.

Other miscellaneous changes

The Hong Kong Offering Documents will also be updated to reflect other miscellaneous, administrative and editorial updates and enhancements of disclosure.

Implication of the changes

Please note that these clarificatory updates do not reflect any change to the investment objective, investment policy, investment strategy or risk profile of the Underlying Fund, and have been made to more clearly describe how the Underlying Fund is currently and will continue to be managed. The updates are not expected to have any material adverse impact on investors' rights or interests (including changes that may limit investors' ability in exercising their rights). In addition, the updates will not result in any change in the current level of fees and charges payable by the Underlying Fund or investors.
