# Various changes to the underlying fund corresponding to the following investment choice of Barings Umbrella Fund plc

Unless otherwise indicated, all capitalised terms in this letter shall have the same meaning as described in the Prospectus dated 5 March 2021, Hong Kong Covering Document dated March 2021 and the latest Product Key Facts Statement of Barings Global Senior Secured Bond Fund (collectively the "Hong Kong Offering Documents").

(the "Investment Choice")

We have been informed by the director of Barings Umbrella Fund plc of the following changes to the underlying fund corresponding to the Investment Choice (the "**Underlying Fund**"). As the unitholders of the Investment Choice, the following changes applicable to the Underlying Fund may have implications for your investment.

## I. Enhancement of risk disclosures on Environmental, Social and Governance ("ESG") integration

To comply with the EU Sustainable Finance Disclosure Regulation (Regulation (EU) 2019/2088) ("**SFDR**"), the Hong Kong Offering Documents have been updated to enhance the risk disclosures regarding the Underlying Fund's approach to ESG integration. The Investment Manager of the Underlying Fund integrates ESG information into the investment process across all asset classes. Please refer to the revised Hong Kong Offering Documents for details.

#### II. Updates to Administration, Depositary and Operating Expenses

Barings Umbrella Fund plc may appoint compliance consultants to assist with anti-money laundering and know-yourclient checks. As such, fees relating to such anti-money laundering and screening services fees ("Services Fees") may be charged to the Underlying Fund under the administration, depositary and operating expenses. Services Fees will not be charged to the Underlying Fund prior to 5 April 2021.

The charging of Services Fees to the Underlying Fund may lead to an increase in the current level of administration, depositary and operating expenses but it is considered that such fees will not have a material impact on the ongoing charges figures of Underlying Fund and Tranches of Shares. In any event, the maximum rate of administration, depositary and operating expenses for the Underlying Fund will not exceed the stated percentage per annum as set out in the relevant Underlying Fund Supplement, and if the actual amount of administration, depositary and operating expenses is lower than the stated maximum, the actual amount will be charged to the Underlying Fund.

#### III. Other miscellaneous updates

The Hong Kong Offering Documents have been updated to reflect other updates such as:

- Update to list of Eligible Securities and Derivatives Markets. For the avoidance of doubt, the updates to the eligible securities and derivatives markets do not represent a change of the investment restriction of the Underlying Fund
- Update of risks relating to investments in China to reflect the removal of investment quota of QFI and RQFII and other updates
- Update of risks related to the Exit of the UK from the EU
- Enhancement of risks related to derivative instruments generally
- Other miscellaneous, administrative and editorial updates and enhancements of disclosures and updates to share classes and underlying funds which are not offered to the public of Hong Kong

## Implication of the changes

Please note that these clarificatory updates do not reflect any change to the investment objective, investment policy, investment strategy or risk profile of the Underlying Fund, and have been made to more clearly describe how the Underlying Fund is currently and will continue to be managed. The updates are not expected to have any material adverse impact on investors' rights or interests (including changes that may limit investors' ability in exercising their rights). In addition, other than the changes detailed in section II above, the updates will not result in any change in the current level of fees and charges payable by the Underlying Fund or the investors.

The Hong Kong Offering Documents have been updated to reflect the changes in this letter and other miscellaneous changes. The revised Hong Kong Offering Documents is available from www.barings.com<sup>1</sup>.

#### Actions to take

You do not have to take any action if you wish to remain invested in the Investments Choices regardless of the above changes. Otherwise you may wish to consider switching the units of the Investments Choices or redirect future regular premiums/contributions (if applicable) to other investment choice(s) through the usual application procedure. No switching fee(s) will be incurred under the current fee structure of your policy.

#### I. 加強環境、社會及管治(「ESG」)融合的風險披露

為了遵守歐盟可持續性金融披露規例(規例(EU) 2019/2088)(「SFDR」),香港發售文件已作出更新,以加強有關該相連基金的ESG融合方式的風險披露。該相連基金的投資經理將ESG資料融合至不同資產類別的投資程序。請參閱已修訂的香港發售文件,以了解詳情。

#### Ⅱ. 行政管理、保管及營運費的更新

霸菱傘子基金公眾有限公司可委任合規顧問以協助進行反洗黑錢和了解客戶的檢查。因此,與此類反洗黑錢及篩查服務費相關的費用 (「**服務費用**」)可在該相連基金的行政管理、保管及營運費項下扣除。服務費用將不會於2021年4月5日前從該相連基金收取。
