Unless otherwise defined in this document, all capitalised terms have the same meaning as capitalised terms used in Legg Mason Global Funds Plc's latest Irish prospectus (the "**Prospectus**") and the Hong Kong Covering Document.

(the "Investment Choice")

We have been informed by the board of directors of Legg Mason Global Funds Plc of the following changes to the underlying fund corresponding to the Investment Choice (the "**Underlying Fund**"), with effect from 9 August 2021 (the "**Effective Date**"). As the unitholders of the Investment Choice, the following changes applicable to the Underlying Fund may have implications for your investment.

# I. Changes to the investment management structure

To reflect an internal reorganisation of investment personnel whereby the current investment team managing the Underlying Fund will move from QS Investors, LLC to Franklin Advisers, Inc.<sup>1</sup>, Franklin Advisers, Inc. will replace QS Investors, LLC as the Investment Manager<sup>2</sup> appointed by the Manager to perform discretionary investment management function for the Underlying Fund with effect from the Effective Date. For the avoidance of doubt, there will be no change to the investment personnel who are currently managing the Underlying Fund.
