We have been informed by Schroder International Selection Fund of the following correction of certain disclosures in the Product Key Facts Statement ("KFS") of the underlying fund corresponding to the Investment Choice (the "Underlying Fund"). As the unitholders of the Investment Choice, the following changes applicable to the Underlying Fund may have implications for your investment.

The performance data of the Underlying Fund's benchmarks, i.e. MSCI Golden Dragon (Net TR) index and Morningstar Greater China Equity Category, were misstated in the "How has the fund performed?" section of the KFS of the Underlying Fund between 30 April 2021 and 21 May 2021. The performance data was corrected in the KFS of the Underlying Fund on 21 May 2021 and has been posted onto the website of Schroder Investment Management (Hong Kong) Limited (www.schroders.com.hk).
