As the unitholders of the Investment Choice(s), the changes applicable to the Underlying Fund(s) may have implications for your investment.

In the Annual General Meeting of shareholders in Legg Mason held on 25 November 2022, the change of the name of Legg Mason, from Legg Mason Global Funds plc to Franklin Templeton Global Funds plc was passed via a special resolution.

In addition, the Directors of Legg Mason approved the change of the names of the Underlying Funds of Legg Mason to reflect the relevant new fund umbrella name. As a result, the names of the Investment Choices will be changed accordingly. Please refer to the table below for details of the name changes of the Underlying Funds and the Investment Choices.
