We have been informed by Janus Henderson Horizon Fund ("Janus Henderson") that changes will be made to the underlying funds corresponding to the Investment Choices (each a "Underlying Fund" and collectively, the "Underlying Funds") with effect from 10 November 2023 (the "Effective Date"). As the unit holders of the Investment Choice(s), the following changes applicable to the Underlying Fund(s) may have implications for your investment.

The terms used but not otherwise defined in this letter shall have the same meanings as those defined in the prospectus dated 29 December 2022 (the "**Prospectus**") of the Underlying Funds, the Hong Kong covering document dated January 2023 of the Underlying Funds and the latest relevant product key facts statements of the Underlying Funds (Collectively, the "**Hong Kong Offering Documents**").

1. Update of the SFDR pre-contractual disclosures of Underlying Funds qualifying as art. 8 SFDR or 9 SFDR Funds

Following the publication of the Delegated Regulation (EU) 2023/363 of 31 October 2022 amending and correcting the regulatory technical standards in the Delegated Regulation (EU) 2022/1288 as regards, inter alia, the presentation of information in relation to disclosures in pre-contractual documents, the pre-contractual disclosures annexed in Appendix 1 of the Prospectus of the Underlying Funds will be updated to include a graphic demonstrating the extent to which the Underlying Funds are exposed to gas and nuclear-related activities that are aligned with Regulation (EU) 2019/2088.

2. Miscellaneous clarificatory, administrative, and clerical updates

The revised Hong Kong Offering Documents of the Underlying Funds reflecting the changes in this letter will be available in due course. The Hong Kong Offering Documents of the Underlying Funds will also be amended to incorporate various miscellaneous, administrative, clarificatory, editorial, clerical updates, formatting changes and the removal of any unlaunched or closed underlying funds.

Impact of the changes

The changes outlined in this letter do not result in any material impact on the Underlying Funds' investment strategies, portfolio compositions, or risk profiles. Except as otherwise disclosed above, there are no other changes to the features of the Underlying Funds. There are no new fees, charges or increases in existing fees or charges borne by the Underlying Funds because of these changes. There will not be a material adverse impact on the rights or interests of the unit holders of the Underlying Funds. There will be no material change in the operation and/or manner in which the Underlying Funds are being managed.

Costs and expenses

The costs and expenses in connection with the changes outlined in this letter will be borne by the relevant Underlying Funds. These costs and expenses will not have a material impact on the fees and expenses incurred by the respective Underlying Funds. The costs incurred in connection with these changes are insignificant by reference to the Underlying Funds' Net Asset Values.

Actions to take

You do not have to take any action if you wish to remain invested in the Investments Choices regardless of the above change. Otherwise you may wish to consider switching the units of the Investments Choices or redirect future regular premiums/contributions (if applicable) to other investment choice(s) through the usual application procedure. No switching fee(s) will be incurred under the current fee structure of your policy.

1. 更新所有符合SFDR第8條或SFDR第9條基金資格的相連基金的 SFDR 訂約前披露

繼歐盟2022 年 10 月 31 日頒佈的授權法規2023/363號(該法規修訂及更正歐盟授權法規2022/1288 號的監管技術標準中有關(其中包括)與訂約前文件中的披露相關的資料呈示)後·該等相連基金的招股章程附錄一隨附的訂約前披露將作出更新·以包括一個圖表·以顯示該等相連基金參與符合歐盟法規2019/2088號的天然氣及核能相關活動的程度。

2. 雜項澄清、行政及文書方面的更新

反映本信件所載變更的經修訂該等相連基金的香港銷售文件將於適當時候提供。該等相連基金的香港銷售文件亦將載入 多項雜項、行政、澄清、編輯、文書方面的更新及格式更改,以及移除任何未推出或已關閉的相連基金。
