Postponement of the proposed changes to the underlying fund corresponding to Aberdeen Standard Liquidity Fund (LUX) - US Dollar Fund - Class A-2 Acc due to take effect on 16 October 2023

Capitalised terms used in this letter shall have the same meaning as set out in the latest version of the prospectus of Aberdeen Standard Liquidity Fund (Lux) ("Prospectus"), the Hong Kong Supplement of Aberdeen Standard Liquidity Fund (Lux) (the "Hong Kong Supplement"), and the Product Key Facts Statement of the underlying fund (the "KFS") (collectively, the "Hong Kong Offering Documents") unless the context otherwise requires.

(The "Investment Choice")

We have been informed by the abrdn Investments Luxembourg S.A. that the proposed changes to the underlying fund corresponding to the Investment Choice (the "**Underlying Fund**") which were communicated to the policyholders on 25 September 2023, set out below, have been postponed.

Any new effective dates which may be proposed will be informed in due course.

For avoidance of doubt, the below changes did not take effect on 16 October 2023:

1. Change of Denomination and name changes to the Underlying Fund and Investment Choice, the name of the Underlying Fund and Investment Choice will remain unchanged.

- 2. Change of Service Providers, State Street Bank International GmbH, Luxembourg Branch will continue to act as depositary and administrator.
- 3. Changes to the Investment Management Fees and the Management Company Charge, references to the "Management Company's Fees" will remain unchanged. The calculation methodology of the Investment Management Fees and Management Company's Fees will remain unchanged.
- 4. Rebranding, the references in the Hong Kong offering documents to various rebranded abrdn entities will be updated at the next available opportunity.
- 5. Removal of fund conversion mechanism for the Underlying Fund

With regard to "Change in pricing applicable to subscriptions and redemption of units of the Underlying Fund" in our letter dated 25 September 2023, it was previously communicated that the Hong Kong offering documents would be updated to clarify that subscriptions and redemptions of accumulation units of the Underlying Fund not carried out at a price equal to the Constant NAV of the relevant class, and instead, are carried out at a price that is equal to the Variable NAV of the relevant class. For the avoidance of doubt, this clarification will be reflected in the Hong Kong offering documents in due course, notwithstanding the postponement of the other changes set out in the paragraph above.

Actions to take

You do not have to take any action if you wish to remain invested in the Investments Choice regardless of the above change. Otherwise you may wish to consider switching the units of the Investment Choice or redirect future regular premiums/contributions (if applicable) to other investment choice(s) through the usual application procedure. No switching fee(s) will be incurred under the current fee structure of your policy.

- 5. 取消該相連基金轉換機制

就我們於2023年9月25日的信件中提及「變更認購及贖回該相連基金單位適用的定價」,香港發售文件將予以更新,以 澄清該相連基金累積單位並非按等於相關類別固定資產淨值的價格認購及贖回,而是按照等於相關類別可變資產淨值的 價格認購及贖回。為免生疑問,雖然如上文所指推遲其他變更,但該澄清將適時反映在香港發售文件中。
