Unless otherwise specified in this letter, all capitalized terms have the same meaning as capitalized terms used in the Franklin Templeton Global Funds plc's latest Irish prospectus (the "**Prospectus**") and the Hong Kong Covering Document.

We have been informed by Franklin Templeton Global Funds plc ("FTGF") that the directors of FTGF decided to approve certain amendments to the underlying funds corresponding to the Investment Choices (each "Underlying Fund", and collectively, the "Underlying Funds"). As the unitholders of the Investment Choices, the following amendments applicable to the Underlying Funds may have implications for your investment.

The Hong Kong offering documents of the Underlying Funds will be updated to reflect the changes as set out herein, as well as other miscellaneous updates, drafting and/or editorial amendments, on or after the Effective Date.
