# Change to the underlying fund corresponding to the following investment choice of Franklin Templeton Investment Funds

Unless otherwise specified in this letter, capitalized terms used in this letter shall have the same meanings assigned to such terms in the Explanatory Memorandum of Franklin Templeton Investment Funds dated April 2024, as amended from time to time (the "Explanatory Memorandum").

(The "Investment Choice")

We have been informed by Franklin Templeton Investments (Asia) Limited, the Hong Kong representative of Franklin Templeton Investment Funds ("Franklin Templeton") that change will be made to the investment management structure of the underlying fund corresponding to the Investment Choice (the "Underlying Fund"), effective from 30 April 2025 (the "Effective Date"). As the unitholders of the Investment Choice, the following change applicable to the Underlying Fund may have implications for your investment.

Currently, the Management Company (Franklin Templeton International Services S.à r.l.) has delegated the portfolio management of the Underlying Fund as follows:

- Templeton Asset Management Ltd has been appointed as the Investment Manager

To reflect an internal reorganization of investment personnel responsible for the investment management of the Underlying Fund, it is proposed that the investment management structure of the Underlying Fund will be revised as follows:

- Franklin Templeton Investments (Asia) Limited will be appointed as an additional Investment Manager, alongside Templeton Asset Management Ltd, to carry out discretionary investment management functions for the Underlying Fund.

Franklin Templeton International Services S.à r.l., Templeton Asset Management Ltd and Franklin Templeton Investments (Asia) Limited are all wholly-owned subsidiaries of Franklin Resources, Inc.

Rest assured, the above change will have no impact on the features and the risks applicable to the Underlying Fund, and will not lead to any change in the operation and/or manner in which the Underlying Fund is being managed or any other effects on unitholders. The investment teams at Franklin Templeton have always managed assets based on a team approach and the Underlying Fund will continue to be managed according to the same principles.

The change set out in this letter are not expected to give rise to any change in the fee level or fee structure of the Underlying Fund. Any costs and expenses arising from the above change will be borne by the Management Company, other than the cost of publishing this letter, which is estimated to be approximately HKD15,000 and which will be charged and allocated to the Underlying Fund and other affected underlying funds based on the pro rata share of the Net Asset Value of the Underlying Fund and other affected underlying funds.

The Explanatory Memorandum and the Product Key Facts Statements of the Underlying Fund will be updated to reflect the above change in due course. An updated version of the Explanatory Memorandum and the Product Key Facts Statements of the Underlying Fund will be available for download from Franklin Templeton's Hong Kong Representative's website at http://www.franklintempleton.com.hk<sup>4</sup>.

You do not have to take any action if you wish to remain invested in the Investment Choice regardless of the above change. Otherwise you may wish to consider switching the units of the Investment Choice or redirect future regular premiums/contributions (if applicable) to other investment choice(s) through the usual application procedure. No switching fee(s) will be incurred under the current fee structure of your policy.
