Change to underlying fund corresponding to the following investment choice of E Fund Unit Trust Fund

Capitalised terms used herein shall bear the same meanings as the capitalised terms used in the Explanatory Memorandum for E Fund Unit Trust Fund and the underlying fund dated 30 June 2025, as may be amended and supplemented from time to time (the “**Explanatory Memorandum**”).

(the “**Investment Choice**”)

We have been informed by E Fund Management (Hong Kong) Co., Limited (“**E Fund**”) of the following change to the underlying fund corresponding to the Investment Choice (the “**Underlying Fund**”), effective from 30 June 2025 (“**Effective Date**”). As the unitholders of the Investment Choice, the following change applicable to the Underlying Fund may have implications for your investment.

Extension of temporary management fee reduction period for Class C of the Underlying Fund (the “Change**”)**

Currently, the management fee rate for Class C Units is temporarily reduced from 0.60% per annum to 0.20% per annum (as a percentage of the Net Asset Value of the relevant class) for the period commenced on 28 May 2025 until 30 June 2025 (the “**Management Fee Reduction Period**”).

As of 30 June 2025, the Management Fee Reduction Period will be extended to 31 July 2025.

With effect from 1 August 2025, the management fee rate for Class C Units will revert to its original level (i.e. 0.60% per annum).

There will not be any change to the operation and/or manner in which the Underlying Fund is being managed. Save as disclosed above, the fee level/cost in managing the Underlying Fund will remain unchanged. The Manager confirms that (i) the Change does not amount to a material change to the Underlying Fund and (ii) there is no material change or increase in the overall risk profile of the Underlying Fund following the Change.

The Explanatory Memorandum and the KFS of the Underlying Fund will be updated to reflect the extension of the Management Fee Reduction Period. The updated Explanatory Memorandum and KFS of the Underlying Fund will be available on E Fund's website www.efunds.com.hk (this website has not been reviewed by the SFC) on or around the Effective Date.

Actions to take

You do not have to take any action if you wish to remain invested in Investment Choice regardless of the above change. Otherwise you may wish to consider switching the units of Investment Choice or redirect future regular premiums/contributions (if applicable) to other investment choice(s) through the usual application procedure. No switching fee(s) will be incurred under the current fee structure of your policy.

我們接獲易方達資產管理 (香港) 有限公司(「易方達」)通知下列有關連繫至該投資選擇的相連基金(稱為「該相連基金」)的變更，於2025年6月30日(「生效日期」)生效。作為該投資選擇的單位持有人，以下有關該相連基金的變更對您的投資或會有所影響。

延長該相連基金C類單位的暫時調低管理費期限(「變更」)

目前，C 類單位的管理費率 (按相關類別資產淨值的百分比計算) 暫時由2025年5月28日至2025年6月30日止 (「管理費調低期」)，由每年0.60%調低至每年0.20%。

自2025年6月30日起，管理費調低期將延長至 2025年7月31日。

由2025年8月1日起，C類單位的管理費率將回復至原有水平 (即每年0.60%)。

該相連基金的運作及 / 或管理方式將不會有任何變動。除上文所披露外，管理該相連基金的費用水平 / 成本將維持不變。基金經理確認：(i)變更並不構成對該相連基金的重大變動及(ii)該相連基金的整體風險狀況於變更後並無重大變動或增加。

說明書及該相連基金的產品資料概要將會更新，以反映管理費調低期的延長。經更新的說明書及該相連基金的產品資料概要將於生效日期或其前後刊載於易方達的網站www.efunds.com.hk (此網站未經證監會審閱)。

應採取的行動
