We have been informed by BlackRock Asset Management North Asia Limited, as Hong Kong Representative of BlackRock Global Funds ("BlackRock") that a change will be made to the underlying fund corresponding to the Investment Choices (the "Underlying Fund"), which will be effective from 16 December 2025 (the "Effective Date"). As the unitholders of the Investment Choice(s), the following change applicable to the Underlying Fund may have implications for your investment.

Terms not defined herein shall have the same meaning as set out in the prospectus of BlackRock (the "**Prospectus**") currently in force (available at www.blackrock.com.hk<sup>1</sup>).

# Change to the Underlying Fund's investment objective and policy section of the Prospectus

The expected level of leverage of the Underlying Fund has been increased from 120% to 190% of the Net Asset Value of the Underlying Fund to improve the Underlying Fund's hedging policy.

There will be no change on the way the Underlying Fund is currently being managed. For the avoidance of doubt, the net derivative exposure of the Underlying Fund will remain to be up to 50% of the Underlying Fund's Net Asset Value.

# Costs

The amendment described in this letter will not result in any increase in the fees and expenses borne by the Underlying Fund and/or its investors. The associated fees and expenses (e.g., mailing costs of the notice issued by BlackRock) will be paid by the Management Company of the Underlying Fund out of the Annual Service Charge charged to the Underlying Fund.
