If you have already created a login account, please take Step 1 (Login) and then jump to Step 5 to give us your consent.



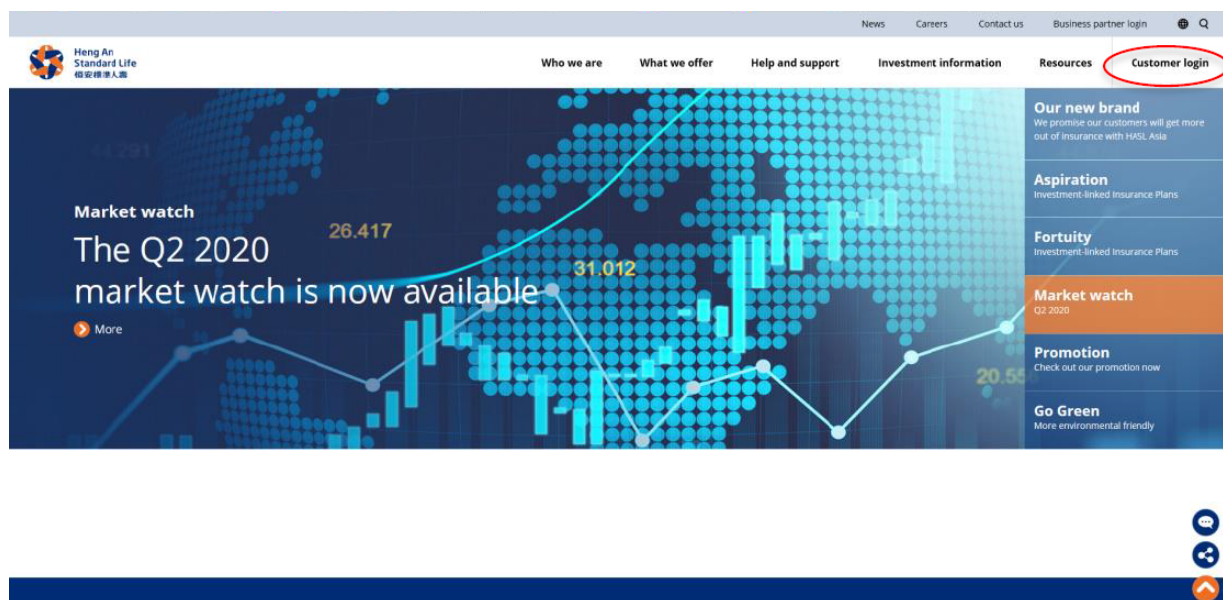




Step 2.1 – Sign up

The user is **required** to provide a policy number to create an account. If the user has multiple policies, only one of his/her policy numbers will be required for initial "Sign up". Each policy number should have a maximum of 8 digits, please enter your policy number for identification verification and press "Next".

2. Your Date of Birth as DD/MM/YYYY

Create online user identity

 - The system only recognises numeric and alphabetic (English) characters and the maximum UserID length is 10
 - The UserID is not case sensitive
2. Your email address



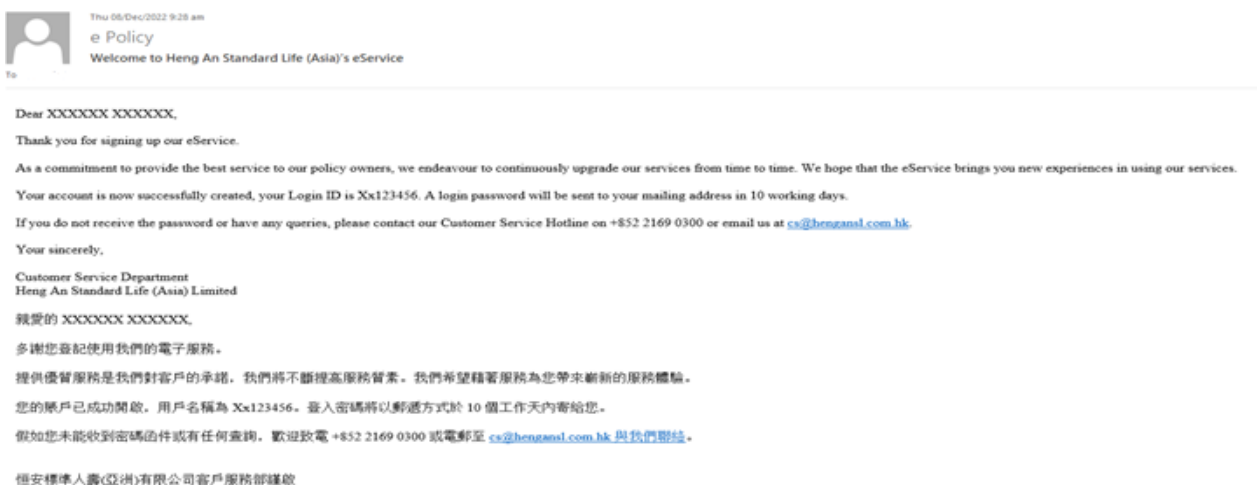



Amendments to the Provisions of "Product Name"
